## **MONTHLY BOARD REPORTS.**

### **Report of the Chair. J. Keith Gilless**

- Expressed gratitude to the Southern Region for the informative tour of Mountain Home Demonstration State Forest (MHDSF). Acknowledged Jim Kral, Forest Manager, for his grasp of knowledge of the challenges that MHDSF faces and his ability to convey those challenges to the Board.

### **Report of the Director/Department. Janet Barentson**

- Director Ken Pimlott is in Washington DC meeting with congressional members regarding forest health issues and the federal fire funding fix initiatives.
- The Director spent a week in West Virginia at the National Association of State Foresters.
- To date, fire start activity is 34% higher this year than average. Last week there were 185 starts, 150 of which were on the State Responsibility Area (SRA).
- The Department has hosted several stake holder conference calls with industry representatives resulting in CAL FIRE representatives serving as liaisons between the incident and the landowners during fires involving private timberlands. This process ensures that land owners are kept informed on incident challenges and progress, and provides for the delivery of landowner concerns directly to the incident commanders. To date, the Department is not aware of any significant issues or concerns on behalf of timber industry representatives related to any of the recent fires.
- Global Super Tanker became a Call When Needed (CWN) vendor for CAL FIRE on August 30th after completing a comprehensive "carding" process by an inter-agency team comprised of CAL FIRE and USFS aviation specialists. Both the aircraft and pilots are carded separately. It was first used on the Ponderosa Fire in Butte County the day it came on contract. Since August 30th, it has flown on 7 different fires across the state, for a total of 15 missions, and delivered 273,028 gallons of retardant. The 747 has a maximum capacity of 18,555 gallons. As comparison, the DC-10 has a capacity of 12,000 gallons and a CAL FIRE S2T air tanker has a capacity of 1,200 gallons.
- The Legislature has passed budget bill Cap and Trade appropriations which includes a full backfill of SRA funds from the Greenhouse Gas and Restoration Fund to maintain the prevention program. In addition, a one-time \$220 million allotment was provided to the Department for urban forestry, forest health and fire prevention activities. The Department anticipates utilizing existing grant mechanisms developed last year to distribute funds for projects with GHG reduction benefits. The law allows the Department up to 3 years to award these funds, and an additional 3 years for the projects to be completed.

- The Department has constituted a steering group to address the need for better reporting from CalMapper. The goal is to have consistent and detailed reporting focusing on project type, location, fiscal year implementation, and funding source.
- The Department has established a Workforce Planning Unit, which includes a recruitment working group. This working group has been focused on improving recruitment efforts surrounding the Deputy State Fire Marshal classes, but is now refocusing on the Forester classes.
