Forest Practice Program

Watershed Protection Program

- The Exemption/Emergency Monitoring Crew has completed 54 percent of the monitoring site samples for the 1038(d) Drought Mortality Exemption. Additional field samples have been scheduled for the month of February 2024. The program expects to complete the sampling and prepare the Exemption Monitoring Report by summer of 2024.
- On December 12, 2023, program staff led the first meeting of the Monitoring Working Group, which seeks to establish common principles for the design and implementation of monitoring programs between the various CAL FIRE Resource Management Programs.
- On December 20, 2023, program staff presented a talk entitled, "Hillslope Runoff and Sediment Production After Wildfire and Post-Fire Forest Management on the Boggs Mountain Demonstration State Forest, Lake County" to the State Water Resources Control Board Wildfire and Forest Resiliency Roundtable Meeting.

Forest Practice Enforcement and Timber Operator Licensing (LTO)

- The CAL FIRE Information Technology Research Development and Innovation Program has automated the LTO Training Class certificate issuance process. It is expected this new application will decrease the time interval between student training completion and certificate receipt and save the LTO Program Coordinator several hours of data entry and mail processing.
- The LTO Program is moving ahead with a zero-dollar contract for online credit and debit card payment for LTO licensing renewals and new applications. This change is expected to provide expedited payment options for the public and a more efficient process for the Department.

Resource Protection and Improvement Program

Urban and Community Forestry

- California will host the Council of Western State Foresters, Urban Forestry Coordinators annual meeting in Sacramento from February 27-29, 2024.
- Green Schoolyards grant agreements were delivered to 29 applicants which will allow activities on approximately 180 K-12 public school campuses statewide.
 Green Schoolyards Childcare Facilities grant applications have been evaluated and awards are in process.

Forest Entomology and Pathology Program

- The disease ghost canker of pines has been found in more areas of southern California outside of Orange County. The disease is caused by the fungi Neofusiccocum mediterraneum and N. parvum. The fungi are known to cause diseases in in grapes and fruit trees but had never before been found in pines. Staff will be surveying to determine the extent of the disease.
- Invasive shot hole borers were found in traps in the City of San Jose. Further surveys found infested sycamore trees in the area and at a site within a mile radius. Surveys found at least 12 infested sycamores including at least two that appear to be acting as "amplifier" trees. "Amplifier" trees produce very high





numbers of beetles to spread to other potential host trees. Samples were collected for DNA analysis to determine the exact species involved. This is the first find of the pest in northern California. A group is forming to work on control and, hopefully, eradication of the infestation.

Forest Biometrics Program

- Stand level information was provided to Lewis A. Moran Reforestation Center for the seed orchard project on a new demonstration state forest (DSF) in the Shasta-Trinity Unit.
- Staff completed the analysis of Timber Atlas Inventory data for Noble DSF and is working on the analysis of Timber Atlas Inventory for Miller DSF, both located in the Shasta -Trinity Unit.

Demonstration State Forests

Sawmill

• The San Bernardino Unit has completed the Sawmill Demonstration State Forest Vegetation Treatment Project (Cal VTP) to conduct 30 acres of prescribed burning, 90 acres of mechanical treatment, 30 acres of manual treatment, and 40 acres of herbicide application under the Wildland-Urban Interface Fuel Reduction Treatment Type. Treatments are expected to begin in early 2024.

Jackson

- Mastication work continues on the Fire Fuels Mitigation Research Project. Two contracted crews, Iron Response and T. Bloyd Excavating, are simultaneously working on the twelve mastication units.
- Recreation Program Manager Erik Wahl continues to assess pygmy forest habitat with State Parks staff for restoration, including introduction of beneficial fire. Consultations with Fish & Wildlife are being scheduled to determine eligibility for the project to fall within the recent addition to PRC Section 21080.56, providing a new Statutory Exemption for Restoration Projects (SERP), part of CDFW's "Cutting the Green Tape" Program.
- Slash pile burning continued on the Red Tail and Chamberlain Confluence THPs. Approximately 40 piles were burned this season.
- Work continues on the Camp One THP, AMEX THP, Pyro silviculture THP, and Emergency Notice for Fuel Hazard Reduction and Forest Fire Prevention Exemptions.
- During the weeks of November 6 and 13, 2023, local reforestation contractor Vasquez Reforestation completed approximately 23 acres of precommercial thinning in the Water Gulch THP group openings.





Prescribed Fire and Environmental Protection Program

Prescribed Fire Program

 Prescribed fire and fuel reduction projects continue to be accomplished taking advantage of the good weather and vegetation conditions. Currently the <u>Interagency Treatment</u> Tracker has 96,463 acres completed for prescribed fire from all of the cooperating agencies. CAL FIRE is reporting 40,205 acres of combined fuel reduction with 20,475 acres of prescribed fire.

Vegetation Management Program

• The Vegetation Management Program continues to use the two programmatic Environmental Impact Reports, the California Vegetation Treatment Program (Cal VTP) and the Chaparral Management Plan (CMP) and other CEQA documents for fuel reduction projects. CAL FIRE has updated the CEQA website to be in compliance with Public Resources Code Section 4137 and the CEQA documents may be found at CAL FIRE CEQA Documents link.

Environmental Protection Program

 The next 5-day CLFA Archaeological course will be offered in March 2024 and the class is already full.

Tribal Affairs Program

 CAL FIRE held interviews for a Tribal Affairs Deputy Director position. Look for an announcement in next month's report.

Cultural Resources Program

 There are two Senior Environmental Scientist positions for Cultural Resources that are in the final stages of hiring. Look for an announcement in next month's report.

Wildfire Resilience Program

Reforestation Services Program

- 257,613 conifer seedlings have been grown for Reforestation Center clients. In addition, approximately 25,000 excess seedlings are now available.
- The Statewide Reforestation Coordinator joined the first meeting of the newly formed CAL FIRE Monitoring Working Group, which is working on developing standards specific to evaluation of seedling plantings unrelated to the Forest Practice Rules.
- The seed bank acquired 126.23 pounds of processed seeds from a total of 210 bushels of cones collected Statewide this season. Next season is expected to have a much larger cone crop.





California Forest Improvement Program (CFIP)

- CFIP closed 2023 with 132 open grants. Of these:
 - o 83 new grants funded in 2023.
 - 49 grants were still open from prior years.
 - For the 83 new grants funded in 2023, \$8 million was encumbered to accomplish the following:
 - 14,802 acres contracted for management plans.
 - 3,573 acres contracted for reforestation and forest health treatments.
- CFIP continues to fund individual projects, with ongoing application selection happing every two months.

Forest Stewardship

- \$500 thousand in grant funding was allocated by the Forest Stewardship Coordinating Committee / California Association of Resource Conservation Districts (Joint Committee). This funding was provided by CAL FIRE for small capacity grants and to allow the Joint Forestry Committee to have direct input on selecting small state grants.
 - 10 grants were awarded in December 2023 and grant agreements are being completed now.
- Staff are completing the final steps to launch a new solicitation to award \$8
 million dollars in Wildfire Resilience Block Grants. This will allow local entities to
 craft a program of technical and financial assistance in a way that is tailored for
 their region.

Forest Legacy Program (FLP)

- Program staff are continuing to advance existing projects and working with CAL FIRE's Grants Management Unit to complete the grant agreements from the 2023 Forest Legacy solicitation.
- No new Forest Legacy solicitations are anticipated in 2024.

Climate and Energy Program

Wood Products & Bioenergy

The Program opened a new solicitation for Business and Workforce
Development Grants on January 16, 2024. Applications will be accepted until
March 8, 2024, and there are up to \$20 million in funds (GGRF) available to
award. This followed a one-week public comment period on the draft grant
guidelines in early January 2024.





 Participated as a panelist at the California Energy Commission's Climate Innovation Program Forests and Agriculture Workshop on December 12, 2023.

Forest Health

- Forest Health closed its FY 2023-2024 solicitation on January 15, 2024. Some preliminary results:
 - Received 66 applications, including 56 standard Forest Health grants and 10 for the pool of funds available for Post-Fire Reforestation and Regeneration
 - Total funding requested: \$329,725,784 for Forest Health (\$120M available to award) and \$57,662,271 for Post-Fire Reforestation and Regeneration (\$50M available)
 - Geographic distribution of applications:
 - North Region (53): AEU 7; BTU 1; CZU 3; HUU 5; LMU 11; LNU 3; MEU 4; MRN 1; NEU 4; SHU 3; SKU 5; TGU 6
 - South Region (13): BDU 1; FKU 1; KRN 1; MMU 5; SLU 1; TCU 2; TUU 2
- Forest Health program executed a grant agreement with Humboldt County for a \$10 million regional pilot supporting the North Coast Resource Partnership. Work continues toward grant agreements for regional pilot awards in the Sierra Nevada and Southern California regions.

Climate Change

- Submitted California Climate Investments end-of-year reporting on Forest Health and Forest Carbon Plan implementation (including Fuels Reduction Crew projects) to the California Air Resources Board.
- Submitted project profiles for two Forest Health projects to the California Air Resources Board to be published as part of the next California Climate Investments Annual Report.
- Provided information to Environmental Protection staff to meet year-end environmental compliance reporting requirements under Public Resources Code Section 4137.
- Began engaging with the California Natural Resources Agency and partner agencies to revise California's Natural and Working Lands Climate Smart Strategy, per AB 1757.

Tribal Wildfire Resilience

 A Tribal Wildfire Resilience grant solicitation is under development for Spring 2024. Tentatively, applications will be due in late spring. Program staff are





working with California Natural Resources Agency Assistant Secretary Geneva Thompson on the solicitation updates and timeline.

- Awarded proposals from the previous Tribal Wildfire grant solicitation continue to move toward finalized grant agreements.
- Program staff attended the Association for Fire Ecology Congress and met with existing and potential grantees and attended presentations about fire ecology and cultural land management.

Wildfire and Forest Resilience Task Force

- A <u>public workshop</u> will be help on February 9, 2024, to gather feedback on a list of proposed Core Metrics that will be used to track and report progress toward resilient landscapes.

Fire and Resource Assessment Program (FRAP)

Forest Health Research Grants

CAL FIRE (FRAP) has released our next Forest Health Research Grant solicitation. The solicitation is open for concept proposals until January 31, 2024. Up to \$4.5 million dollars from the Greenhouse Gas Reduction Fund will be awarded from this solicitation. Research proposals from this solicitation will lead to scientifically rigorous studies that help us evaluate climate impacts on forests and understand the effectiveness of management actions designed to promote wildfire resilience. Wildfire Science

CAL FIRE's Board Representative attended a San Jose State University's
Business and Industry Agreement meeting for wildfire science research group in
mid-January 2024. This is a National Science Foundation sponsored
arrangement where members vote to support short-term research projects.





- FRAP gave a presentation for the National Institute for Science and Technology/ NIST/National Oceanic and Atmospheric Administration/American Society of Civil Engineers Workshop Series: Leading Practices for Use of Climate Projections in Community Resilience Planning and Design of Buildings and Infrastructure.
- FRAP organized a research and monitoring workshop at a Fire Ecology workshop (AFE) in December; over 80 attendees. Program staff are working on a white paper to summarize the workshop findings.

Forest and Rangeland Assessment

FRAP is targeting the second quarter of 2024 for completion and public release.
 Expect draft chapters to be completed by end of January.

Adaptive Management Experiments (AMEX)

- A prescribed burn was conducted on our AMEX site at LaTour. That completes
 the implementation of the experiment at that site.
- A 3-year maintenance agreement has been executed for AMEX.

Fire Protection

Fire Protection Program

Law Enforcement/Civil Cost Recovery

- In 2023, CAL FIRE Law Enforcement officers made a total of 248 arrests and issued 544 citations.
 - Of the total arrests, 111 were for Arson.
- In fiscal year 23/24, \$74.7 million has been collected by Civil Cost Recovery.

Fire Protection Operations

 There are seven CAL FIRE personnel that have passed the S590 Fire Behavior Analyst pre-test, this is the most we have sent at one time, nationally 35 passed the exam

Aviation Management Unit (AMU)/Tactical Air Operations (TAO)

- NSW Rural Fire Service requested assistance with airspace management strategies in response to fire activity and complexities experienced in October and November. Collaboration occurring through a series of virtual meetings
- Five flight crew personnel from Colorado Division of Fire Prevention and Control (DFPC) are attending S70i Front Seat Initial training between January 22 and February 9, 2024.





 State of California has taken ownership of seven C-130H aircraft, allowing for CAL FIRE (AMU) to take lead on the next phase in the process, which is installation of the retardant delivery systems. AMU is in the process of acquiring the tanks

Mobile Equipment Program

• Working to complete the 2024/25 Fleet Acquisition Plan by March 2024.

Cooperative Fire Protection

Local Government Program

 The Local Government Program transitioned the four 2024 Local Government Workshops from in-person to virtual. This was done in effort to reduce expenditures as requested by the Department of Finance Budget Letter. This modified workshop will provide guidance on cooperative fire protection agreements, policy updates related to agreement staffing requirements, and reconciling employee/agreement billing.

State/Federal Programs

The State, Federal, and International Program drafted an Emergency
Management Assistance Compact (EMAC) Policy (8514) which was presented to
the CAL FIRE Department Leadership Team. This updated policy covers the new
EMAC Policy giving direction on ordering/receiving equipment, billing, and paying
invoices from other states.

Hand Crew Program

• The Hand Crew Program transitioned the 2024 Hand Crew Workshop from inperson to virtual to reduce expenditures as requested by the Department of Finance Budget Letter. To meet the intent of the in-person workshop, the Hand Crew Program has been working with cooperators, developing a virtual conference scripting and efficient delivery method based on original in-person agenda items. The goal is to limit the amount of time online while still providing essential information sharing.

Safety/EMS Program

Safety Program

 The Wildland Firefighting Protective Ensemble Specification has been updated and distributed to all employees. The updates include removing the fire resistant additive from the silkscreen ink and moving the responsibility for the inmate firefighter orange silk screening to Salt Creek and Cuesta Camps due to the changes at CalPIA.





- Several Temporary Directives are under development to address PPE care and maintenance while the corresponding policies are in the approval process.
- The Safety Program is working to define rain and cold weather gear as PPE in policy. These policies are in the approval process. This project will identify a specification for these items to make the purchasing process standardized. The Business Services Office (BSO) and Uniform Advisory Committee (UAC) are engaged with Safety in these discussions.
- Due to the concerns of Lithium-Ion batteries and the ability to properly clean PPE
 after these incidents, the Safety Program is creating a contract for CO2 PPE
 cleaning. This contract will allow the Department to utilize these services soon
 and this request is being expedited by BSO. This contract is anticipated to be in
 place by March. Thank you to BSO for their assistance in helping Safety explore
 options for this unique service with limited vendors while understanding the
 immediate need for this capability.
- The annual vehicle accident statistics forms (ME-60) are currently being completed by the Units/Programs and routed to the Safety Program for creation of the annual report. This year's report will be different than past years due to the changes in the vehicle accident report process which includes a distinction between accidents and incidents.
- Facility IIPP binders are undergoing their annual review. An updated Covid Prevention Plan was recently sent out due to regulatory changes.

EMS Program

- The EMS Program has begun building the "test site" for the integration of CALFIRS and CALePCR. This test site will allow the Program to validate the interoperability of the two programs and the planned upgrades. The Unit EMS Coordinators have been asked for information to aid in the gathering process.
- Handbook 7243, Burn Injuries and Treatment, has been updated. The biggest change is the addition of 20CRW which is 20 minutes of cool running water in the first three hours. We are one of the first departments in the nation to implement this new procedure for the treatment of burns to our employees. Program will host several Teams meetings for the field on the new policy.

Statewide Training Program

- Effective February 5, 2024, Staff Chief Catherine (Cat) Frazer will have oversight of the Training Program, which includes Statewide Training and the CAL FIRE Training Centers.
- On January 1, 2024, Andrew Kibby was promoted to Statewide Training as an Assistant Chief with responsibility for Statewide training courses involving





Command and Control Staff positions. Chief Kibby previously held the position of Battalion Chief, Training Bureau, Riverside Unit.

 Statewide Training is currently planning to provide approximately one hundred courses in 2024, including five sets of Continued Professional Training (CPTs) to cover Basic Fire Protection Knowledge and Skills Examinations annual required training.

Academy Training Program

- In the last two months of 2023, Battalion Chief Mike Weidner, Fire Captain Rob Engel, and Assistant Chief Sean Sunahara retired.
- 2024 Academies began on January 8, 2024, in Ione Law Enforcement Regular Basic Course (RBC), Company Officer Academy, Firefighter Academy, and Emergency Command Center Academy
- RBC has 32 students in the class, a record number for the course.
- Training Center North began an 11-week Fire Control Training Academy on January 15, 2024.
- Recruitment of Food Service personnel continues to be a challenge, requiring a contract for dinner meals.

Office of the State Fire Marshal

Wildfire Risk Reduction

- Wildfire Mitigation Advisory Committee:
 - Wildfire Mitigation Advisory Committee is meeting again on February 20, 2024, where the Committee will receive a presentation from the Board of Forestry and Fire Protection on a brief update on the timing status of the regulations for Zone Zero as well as a presentation from the California Department of Insurance (CDI) on the framework for "Safer from Wildfires".

- CAL FIRE staff have released a new Wildfire Home Hardening website which includes a Home Hardening Self-Assessment Application. https://www.fire.ca.gov/home-hardening
- Utility Wildfire Mitigation Program:
 - Personnel continue to consult on the Wildfire Mitigation Plans (WMP's) for the Independent Transmission Operators (ITO's), Liberty, and PacifiCorp.
 - The ITO's will be finalized and published on January 29, 2024.
 - Liberty will be finalized and published on February 5, 2024.
 - PacifiCorp will be finalized and published February 12, 2024.
 - As of January 1, 2024, personnel have spent over 450 hours in meetings and have been involved in 14 management reviews for the current WMP filing process.
 - Scheduling a training session for Office of Energy Infrastructure Safety (OEIS) and other agencies for mid-Mach to go over PRC 4292/4293, powerline equipment identification and inspections.
 - Continuing to work with a few utilities and manufacturers for the Public Resource Code 4292 Equipment Exemption process.
 - The review and update of the 2024 CAL FIRE Power Line Fire Prevention Field Guide Communication Clearance process (CAL FIRE 330) continues to move forward through all the signatory process.

Wildfire Planning and Statistics

- State Responsibility Area (SRA):
 - CAL FIRE Office of the State Fire Marshal submitted the Final Statement of Reasons for the State Responsibility Area Fire Hazard Severity Zones to the Office of Administrative Law on December 15, 2023.

- Pre-Fire Planning:
 - Units have been validating a last review of DPA recommendations.
 - Annual Facility dataset edits will be finished in January.
 - 5-year SRA review will begin summer of 2024, to be concluded June 2025.
 - Community Wildfire Protection Plan (CWPP) development/toolkit is ongoing.
 This will ensure a level of consistency across local & regional plans.
 - Continuing to develop the Fuels Treatment Effectiveness reporting mobile application, report templates and dashboard.
 - Unit are starting the annual Fire Plan update, due late spring.
- Wildland Fuels Reduction Reporting:
 - CalMAPPER QA/QC
 - Units and Grant programs completed their QAQC for data back to fiscal year 19/20.
 - Detailed Fuel Reduction Report
 - December acres were reported on January 10, 2024. We updated the Fiscal Year numbers back to FY 19/20.
 - CNRA Tracker Extract
 - The report locking on January 10th coincides with the CNRA Tracker extract that will start to take place at the end of the month. This is all by design to ensure that CNRA data is aligned with CAL FIRE data.
- CalStats:
 - Redbook Quality Control & Outstanding CALFIRS Reports:
 - Continuing the Redbook Review Dashboard for CAL FIRE and the Contract County Quality Control list, and subsequently uploading it to the Contract County SharePoint site.





 Addressing discrepancies in acreage within our current Large Fire List (300 acres or more), which exhibited variations in reported acreage between FRAP perimeter, CALFIRS, 209 reports, and CAD.

o NERIS:

- Collaborating with the west coast Office of State Fire Marshal's on the future implementation of NERIS (National Emergency Response Information System)
- Working with other CAL FIRE programs, state agencies, and local fire departments on gathering feedback for the Draft Core NERIS Data Framework and Schemas that include fire department specifications, computer-aided dispatch, and incident data that will make up NERIS which replaces NFIRS (National Fire Incident Reporting System) in 2025.

Wildfire Ignition Data:

- Working with Federal partners on uploading National Association of State Foresters (NASF) ignition data from the last three quarters to examine the data's presentation and identify any potential issues that may require attention.
- Collaborating with Pre-Fire staff to enhance the accuracy of current ignition locations, thereby improving the reporting utilized by various agency programs.
- Implementing changes and conducting reviews of location data reported in CALFIRS reports to ensure ease of continuous quality improvement (CQI) for reviewers.

Community Wildfire Mitigation Assistance

- Land Use Planning:
 - Staff continue working with jurisdictions to update the local Safety Elements in their General Plans statewide.
 - 30 jurisdiction Safety Elements were successfully updated and reviewed by the Board of Forestry (BOF) in 2023.

NFPA Firewise USA:

- Currently 784 communities in good standing. This number may fluctuate over the next few weeks as we work with National Fire Protection Association (NFPA) to finalize the yearly renewals.
- Firewise application renewals were due by December 15, 2023. NFPA provided a two-week extension due to website portal issues.





- Subdivision Review Program:
 - 50 Fire Safety Surveys including Contra Costa County, City of Corona, City of Riverside and City of Malibu were sent to RPC meeting January 23, 2024.
 - Staff will be conducting field surveys in Marin County in February 2024.
 - Continued collaboration meetings with many statewide jurisdictions.
- Fire Safe Regulations Workgroup:
 - Committee continues building course curriculum for training on "How to Implement the Fire Safe Regulations".
 - Planning to hold pilot course later this year.
- o Introduction to Land Use Planning for Wildfires in California course:
 - Registration now open for at least 10 training dates in 2024
 - Register at www.communitywildfire.org/trainings
