6 Article 4 Fire Safety Survey

7 § 1267.00 Definitions

8 Dwelling unit: A "dwelling unit" has the same definition as a  
9 "residential unit" below.

10 Local responsibility area (LRA): Those areas of land classified  
11 by the Board of Forestry and Fire Protection (Board) where the  
12 financial responsibility of preventing and suppressing wildfires  
13 is not that of the state or federal government, pursuant to  
14 Public Resources Code (PRC) 4125.

15 Residential unit: Any building or portion thereof which contains  
16 living facilities, including provisions for sleeping, eating,  
17 cooking and/or sanitation, for one or more persons. Manufactured  
18 homes, mobilehomes, and factory-built housing are considered  
19 residential units (14 CCR § 1271.00).

20 Road: Any surface designed, improved, or ordinarily used for  
21 vehicle travel. Includes public and private streets and lanes.

22 State Responsibility Area (SRA): as defined in Public Resources  
23 Code 4102.Subdivision: an existing development of more than  
24 thirty (30) residential units, not necessarily subdivided as  
25 defined in Government Code 66424.

1 Very high fire hazard severity zone (VHFHSZ): as defined in  
2 Government Code 51177(i) and identified pursuant to Government  
3 Code 51178.

8 § 1267.01 Fire Safety Survey

9 (a) On or before July 1, 2021, and every five years thereafter,  
10 the board, in consultation with the State Fire Marshal, shall  
11 survey local governments, including counties, cities, and fire  
12 districts, to identify existing subdivisions without a secondary  
13 egress route in all SRA or LRA mapped as a very high fire hazard  
14 severity zone.

15 (i) A secondary egress route is a road, navigable by class  
16 one vehicles as defined by the Federal Highway Administration,  
17 of equal construction standard to the primary road (e.g., two  
18 paved roads). The secondary road does not have to be rated to  
19 carry the same quantity of traffic (e.g., a two-lane paved road  
20 and a one-lane paved road is acceptable).

21 (ii) A secondary egress route is not:

22 (A) a road with locked gates or limited access; or

23 (B) a road that directs traffic to the same outlet  
24 road as the primary road or results in a circular  
25 traffic flow, to the extent practicable.

1 (b) Local government officials, including elected officials,  
2 fire officials, or representatives of agencies that govern land  
3 use planning and subdivision design, may request the board and  
4 the State Fire Marshal survey specific subdivisions in their  
5 jurisdiction.

9 § 1267.02 Fire Safety Recommendations

10 (a) The board, in consultation with the State Fire Marshal and  
11 the local government that identified the subdivision, shall  
12 develop recommendations to improve the subdivision's fire  
13 safety.

14 (b) The board shall provide the final recommendations developed  
15 pursuant to § 1267.03(a) to the local government that identified  
16 the subdivision and to the residents of the subdivision.

20 § 1267.03 Implementation Monitoring

21 (a) The board shall maintain a list of the subdivisions  
22 identified in § 1267.01.

23 (b) The board shall track the status of the implementation of  
24 the recommendations provided pursuant to § 1267.02.
