## **MONTHLY BOARD REPORTS**

### **Report of the Chairman, Dr. Keith Gillless**

Chairman Gillless reported on the following matters:

Welcomed Director Thom Porter and congratulated him on his recent gubernatorial appointment as CAL FIRE Director.

### **Report of the Director, Thom Porter**

Director Porter reported on the following matters:

#### **Fire Statistics - 2018**

- 1.8 million acres burned on Federal, State and Local land.

- 867,000 acres burned on State Responsibility Area, almost 4 times the 10-year average.
- Largest fire: Mendocino Complex
- Camp Fire/Butte County: Most destructive and deadliest in California history.
- Carr Fire: Exhibited unusual behavior and patterns.
- 23,000 structures destroyed and 1,400 damaged.
- 100 fatalities; 6 were emergency responders.

Director Porter shared a success story about how the Cranston Fire had reached and flanked the community of Idyllwild in Riverside County. As it reached a fuel break, it turned and missed the town. The fire would have destroyed the heart of Idyllwild had it not been for the fuel break. The fuel break has been in place for 20 years and was instrumental in saving the community.

### **Fuels Treatment Goals and Statistics**

- Prescribed fire: Goal - 25,000 acres; 38% have been completed (9,500 acres burned)
- Fuels Reduction: Goal - 20,000 acres; 21% completed (4,200 acres)
- Defensible Space Inspections: Goal - 250,000 inspections; 38% completed (95,000 inspections)

### **Budget**

CAL FIRE has been meeting with the Legislature and working through Budget Change Proposals (BCPs). Several of the proposals were worked on with Governor Brown's Administration and have carried over to Governor Newsom's Administration. The changes include:

- Enhanced Fire Protection Resources: \$95 million that will bring 223 positions to Fire Protection and enhance engine, bulldozer and fire crew staffing.
- Converting 5 additional CCC crews from Reimbursement Crews to fulltime, Type I Fire Crews.
- 13 new engines that will be staffed year-round. This will bring the engine count from 343 to 356.
- Development of a Health and Wellness Program; CAL FIRE is developing an internal program to help reduce the long- and short-term effects of deployments on employees.

### **Legislation**

- Senate Bill 901 will add to the Department's and Board's workloads. A BCP was submitted that will allow for additional positions to support the added workload. This includes \$35 million for Prescribed Fire; CAL FIRE is in the process of building 10 fuels crews that will be dedicated to the fuels mission and provide Initial Attack at the local level. Additionally, \$5 million of the \$165 million will go directly to CCC to support their fuel reduction projects and logistics. The remainder will go to Administrative costs and grants for larger fuel reduction projects.
- The Department is accepting grant proposals for projects that address fire prevention at the landscape level. The review process should be complete by the end of February and results will be announced in March.
- Executive Orders specific to CAL FIRE:

- Order #4 is a procurement sprint - a new type of procurement that looks for a solution to a problem. The Order requires CAL FIRE to lead a discussion with its partner agencies and collaboratively propose the first problem statement. The problem statement will include how to reduce the detrimental effects of wildfire. The process will look for innovative ideas to address the problem statement. The Director will provide updates in the coming months.
- Order #5 is a 45-Day call for a report from CAL FIRE to narrow down Tier IA areas. A Tier IA is an area that is adjacent to a wildfire vulnerable community. The intent is to identify projects that can be undertaken within close proximity of these areas to reduce the chance of another devastating wildfire. The report will be presented to the Governor on February 22; decisions on how to proceed beyond the initial report will be considered and may include an Executive Order or an Emergency Declaration.

Tiaga Takahashi, Rancho Guejito, online submission, he wrote: “Unfortunately, Rancho Guejito cannot support the proposed CRM regulations. The proposed regulations do not address the ranch’s concerns regarding the enforcement of good moral character requirements and actually lessen protection for the public with the most recent suggestion being based on an idea of one of the members of the PFEC and only one page, along with legal and other research regarding good moral character requirements in other state licensing programs, but they have all been ignored.”

**Agency Comment**

Eric Huff, CAL FIRE, Staff Chief, Forest Practice Program, commented, CAL Fire is in support of the Rulemaking, but there are concerns going forward about certain language within the rule text, however, CAL FIRE realizes that there’s an opportunity for further revisions in the future.

Isabel Baer, California Department of Fish and Wildlife Commended Board staff on their efforts on the rule package in such a short time.

**Public Comment**

Gary Ryneanson, Green Diamond offered his insights on the interpretation of the language. Supports the term “OLD AND BIG” instead of “OR” keeping with the existing language in the 1038.6 exemption. Thanked the Board and Board staff for putting the rule package together in 23 days, it is an important piece of emergency regulation that will enable landowners to move forward with projects.

Cedric Twight, Sierra Pacific Industries expressed concerns with the change from AND to OR, for large, trees. The language should be left as is.

John Anderson, Mendocino Redwood Company and Humboldt Redwood Company expressed concerns with 1031.1 c 4,5,6 and 7 that was revised to 1031.1 c,5 which make it seem as if all of c applies to forest fire prevention. He also mentioned the diameter limit, trees over 30” cannot be harvested, this is tabled in under the temporary road section of the exemption, it applies to the entire section, he commented, it should have its own section.

Elliot Chasin, California Department of Fish and Wildlife commented to clarify, that regardless if you change the OR to an AND or vice versa, in statute it’s still very simple to make a case.

He said that he was glad to see synchronization but wanted it to extend to cumulative impacts on watersheds. He was also glad that lumber taxes went to monitoring real situations and is excited about the Rynearson pilot project. However, he believes that small landowners don't have the capacity to do monitoring and that the state needs to take on this responsibility. He also believes that the planning watershed is too small of a unit to focus on and that future pilots should focus on

larger units. He also stated that greater stakeholder involvement is needed, and more integrated involvement.

**Richard Gienger, Forests Forever**, commented that with AB 901, standards for thinning, prescribed fire, and incentives for landowners are needed.


