Resource Management

Forest Practice Management

Forest Practice Administration

- The 2023 Forest Practice Rules are posted to the Board of Forestry and Fire Protection website. Hard copies are anticipated to be published by the end of February.
- Due to increased Region Forest Practice staffing and a lower than anticipated number of harvest document submissions, Headquarters Program staff have been able to reduce their level of assistance with harvest document review at the Santa Rosa Forest Practice office.

Watershed Protection Program

- Watershed Protection Program Manager, Drew Coe, and Forest Practice Monitoring Coordinator, Will Olsen, collaborated with Dr. Joe Wagenbrenner from the USFS Pacific Southwest Research Station to produce CAL FIRE California Forestry Report No. 7 entitled "Mitigating Potential Sediment Delivery from Post-Fire Salvage Logging." The Report will soon be available to the public and a shorter summary version of the document is in development.
- Interviews were conducted for the vacant Forester II-Forest Practice Monitoring Coordinator position vacated by Drew Coe when he promoted to Watershed Protection Program Manager. The hiring review process is nearly complete for the selected candidate.

Resource Protection and Improvement Program

Urban and Community Forestry

- Urban and Community Forestry and School Greening Grant guidelines are posted for public comment, closing January 13, 2023. Requests for applications will be opened after the public comment period closes and appropriate edits are completed to the grant guidelines.
- A funding advice letter was received from the United States Forest Service regarding funds available from the Inflation Reduction Act. CAL FIRE will likely be submitting a request for a portion of \$1.5 Billion available for Urban and Community Forestry state administered sub-grant programs.
- The program sponsored and hosted a national urban wood utilization summit at Palomar College in San Marcos. There were about 50 attendees from all over the United States.
- The Summit included a tour of the Taylor Guitars factory in El Cajon where they use Shamel ash (*Fraxinus uhdei*) and red ironbark Eucalyptus (*Eucalyptus sideroxylon*) wood sourced from urban settings in California to manufacture two unique lines of high quality guitars. Their supplier is Street Tree Revival that began scaled up operations in urban wood utilization as a result of a CAL FIRE grant to the Britton Fund in 2017.

- Palomar College’s School of Fine Woodworking mills donated urban logs from the greater San Diego area with a portable sawmill that they originally received from CAL FIRE in 2003. Their students use the wood to make their projects.
- Initial planning is underway to develop a statewide strategic plan to increase urban tree canopy by 10% by 2035. The strategic plan is due to the California Legislature by June 30, 2025.

Prescribed Fire and Environmental Protection

Prescribed Fire

- The most recent prescribed fire Claims Fund collaborative meeting was on January 11th. The group is trying to meet every two weeks. Currently the design is to have 200 policy reservations to cover projects in the event of an escape that causes damages. Several partners are involved in the process per the requirements in the legislation (SB 926).

Vegetation Management Program

- The California Vegetation Treatment Program Environmental Impact Report (CaIVTP) continues to be used. Currently, CAL FIRE has 9 VTPs in the Northern Region and 4 VTPs in the Southern Region. There is a total of 35 VTPs listed on the [Board of Forestry and Fire Protection website from all lead agencies](#).
- There are currently 97 Chaparral Management Plans (VMPs) that are open for CAL FIRE.

Environmental Protection

- The next CEQA for CAL FIRE Projects training is scheduled for February 27th to March 3rd in Los Osos.

Tribal Affairs/Cultural Resources

Tribal Affairs

- The next Cultural burn awareness class is going to be in the southern region in the Palomar area (Northern San Diego County) on January 17th. The class is at full capacity and registration is closed.
- CNRA and CAL FIRE Forest Health Program provided a round table discussion for the Tribal Wildfire Resilience Grants. The solicitation period for this grant is open until March 14th.

Cultural Resources

- The California Licensed Forester Association and CAL FIRE have scheduled the next round of the Cultural Resources Training courses. Please review the CLFA newsletter for more information and sign up for the training.

Reforestation Services

- A total of 207 pounds of seed was sold in 2022 accounting for 17 orders.
- A total of 193,526 seedlings grown in 2022 accounting for 20 orders between a mix of landowner types (Demonstration State Forests, Resource Conservation Districts, Non-Profit/Trusts, Private Landowners). Efforts continue to expand our growing space through constructing additional greenhouses and other improvements to the facility.
- The online request form remains open for parties interested in procuring seed to be grown off-site as well as for parties interested in excess seedlings, primarily in the Dixie and Caldor fire scars.

Demonstration State Forests

Jackson

- The Jackson Advisory Group has announced the dates of their 2023 meetings: Wednesday, March 15; Tuesday June 6; Friday, September 15; and Wednesday, November 15. Meeting locations and agendas will be posted no later than 10 days prior to each meeting.
- The Caspar-Big River Recreation Map has been created to illustrate campgrounds, roads, trails, and facilities in the popular recreation areas of Mitchell Creek, Jughandle, Caspar and Big River drainages. The map also includes features in adjacent State Parks. A metal backed copy of this map has been posted at the Caspar “scales” kiosk and it is available online for download as a georeferenced PDF document to aid in navigation of this part of the forest.

LaTour

- Nothing new to report.

Mountain Home

- CAL FIRE participated in a Giant Sequoia Lands Coalition media event on December 14 at Calaveras Big Trees State Park to highlight the accomplishments of the coalition in 2022. The Coalition also announced the creation of a new website, <https://giantsequoias.org/>, at this event.

Soquel

- Soquel was closed to public access on January 3 due to dangerous conditions including downed trees, active mudslides, blocked access roads and hazardous trails resulting from storms. The re-opening date will be determined based on public safety.

Forest Biometrics

- The Request for Proposals for the 7 Forest Inventory Analysis (FIA) Temporal Intensification contracts were posted December 23. The final submittal date for proposals is January 25.

California Forest Improvement Program (CFIP)

- CFIP has accepted approximately \$1,000,000 in small landowner projects for our December 31, 2022 cut-off. CFIP will be selecting CFIP applications every 2 months to deliver approximately \$2 to \$3 million each period as funding allows.
- CFIP raised cap rates twice in 2022 – field foresters for CFIP state that they have seen an increase in projects, and RPF's interested in taking on projects, directly as a result of the rate increases.
- There are no plans to offer a Wildfire Resilience Block Grant solicitation due to lack of funding. Current grant projects continue to complete their work.

Forest Legacy Program (FLP)

- Al Klem, Forest Legacy Program Coordinator retired on November 30, 2022. Al was instrumental in helping to grow the Forest Legacy Program.
- Two Legacy, CCI funded projects closed at the end of 2022:
 - Wagner Forest Conservation Easement – Held by Northcoast Regional Land Trust. The total grant from CAL FIRE was \$2,750,000 in CCI funding, conserving 3,348 acres of forestland in Humboldt County.
 - Silva Ranch Conservation Easement – held by California Rangeland Trust. The total grant from CAL FIRE was \$4,050,000 CCI & \$1,060,000 Forest Health funding, conserving 4,340 of forestland in Sonoma County.
- Plans are being made to offer a Forest Legacy Grant solicitation in early 2023.

Forest Pest Management

- Joshua Trees (*Yucca brevifolia*) are seeing greatly increased mortality due to the yucca weevil (*Scryphophorus yuccae*) in southern California. Joshua tree has not been listed as a common host of yucca weevil in the past. The extent of the infestation is not yet known, but the extensive damage has been seen in Joshua Tree National Park and surrounding areas.
- A new Gold Spotted Oak Borer (GSOB) location has been found in Hemet, CA. Surveys are being coordinated and will include the surrounding areas to determine infestation size.
- Mediterranean Oak Borer (MOB) has been detected in 5 counties in Oregon in and around Portland. Staff is working with the Oregon Department of Agriculture to determine the invasion rout. International shipping is suspected, and the working hypothesis is that they are the result of an introduction independent of the California infestation. The hypothesis will be tested through DNA analysis.

- Emerald Ash Borer has been detected in Oregon. Staff is working with the CAL FIRE Seed Bank in Davis to collect and store seed from native ash. In 2022 staff carried out a single pilot collection to assess time and storage needs per collection. In 2023 staff will collect as many seeds as practical given time and storage constraints. Efforts are being coordinated with The Huntington Arboretum Seed Collection and the United States Department of Agriculture (USDA) seed bank.
- Staff consulted with Resource Management personnel at Calaveras Big Trees State Park concerning sequoia flagging and potential mortality from bark beetle and other cambium feeding insects. The plan is to monitor in the canopy in spring 2023 and, in coordination with their tree climbing consultants, to set traps and collect cambial samples from branches in the upper canopy.

Climate and Energy Program

Wildfire and Forest Resilience Task Force

- Southern California Regional Task Force Meeting, February 2-3, 2023: Santa Monica Mountains Conservancy and Mountains Recreation and Conservation Authority are hosting the Southern California Regional Meeting of the Task Force, in person at the historic [King Gillette Ranch](#) in Calabasas and online via [livestream](#). [Registration is required](#) for in-person attendance, as space is limited. Same day, in-person registration is not available. Forest Health Program

- Forest Health launch the FY 2022-2023 grant solicitation on December 15. This grant solicitation includes four different grant types including Forest Health, Post-Fire Reforestation and Regeneration, and Tribal Wildfire Resilience Planning. The solicitation for all four grant types closes on February 28.

Wood Products & Bioenergy Program

- Opened new solicitation for business and workforce development grants, which includes \$5 million for biomass transportation subsidies.
- Attended the Firetech event in San Francisco on December 6. The event brought start-ups, venture capital and government together for networking and discussions of business approaches to addressing wildfire mitigation.
- Released a joint press release with Sierra Pacific Industries in December to announce partnership in their plans for a new 25 million/year conifer tree nursery in Gazelle.
- Presented at a media event in Fresno on December 7 to announce grant funding for the Central Valley Forestry Corps- Reedley and Mother Lode colleges.

Climate Change

- Submitted semi-annual California Climate Investments reporting data to the California Air Resources Board for the Forest Health and Fuels Reduction Crews programs.
- Submitted project profiles highlighting the Forest Health program for the California Climate Investments Annual Report.

Fire and Resource Assessment Program (FRAP)

Fire Hazard Severity Zones (FHSZ)

- The FHSZ update for SRA is open for public review. FRAP staff are assisting OSFM in response to public comments relating to FHSZ model update.

Forest Data Hub

- FRAP is entering into an agreement with the Climate Wildfire Institute on the development of an Early Phase Data Hub. This is expected to be implemented as a 3-year Research Grant. FRAP is coordinating with IT Staff on the Scope of Work.

Forest Health Research Grants

- Due to technical issues in implementing a new grants software system the Forest Health Research Grant solicitation has been delayed.

Prescribed Fire Monitoring

- Following a successful fall prescribed season, attention now turns to data management, preparedness for winter burning, and 2023 planning. Work continues on establishing new agreements with UC Davis and Chico State to support and expand prescribed fire monitoring. The Prescribed Fire Monitoring program is also working with Climate and Energy to provide field monitoring protocols that meet reporting requirements under AB 203.

Forest Inventory Analysis (FIA)

- New Request for Proposal for 2023 and 2024 FIA data collection field seasons is open for bids. FRAP will work with staff from Biometrics to review and score proposals.
- The USFS drafted an amendment to the existing FIA Collection Agreement to extend time through March 2024.

Fire Protection

Law Enforcement/Civil Cost Recovery

- During the year 2022, CAL FIRE Law Enforcement officers made 162 arrests.
- CAL FIRE Law Enforcement Program has completed the statewide Axon Record Management System training and is now in use statewide.

- The 2022 CAL FIRE Post Recruit Basic Training started this week at the California Fire Training Center (CFTC) with 24 cadets.
- Program and Region have begun the 2024 peace officer candidate background process.

Aviation

- The annual Department Aviation Safety Conference was held the first week of the year. This event held in Sacramento hosts personnel from all of our aviation bases as well as invitees from our Federal and Local Government cooperators.
- We have completed the process to award a contract to our aviation logistics contract and are working with Business Services to finalize the process.
- CAL FIRE has 4 staff in Arizona assisting with instruction at the National Aerial Firefighting Academy where we work with our federal cooperators on providing aerial supervisors for air tanker pilot training.
- CAL FIRE Tehama Glenn Unit, Vina Helitack Base, will begin its night operations training this month.
- We continue to monitor the progress between the United States Coast Guard and United States Air Force on the C130 Retardant Delivery System installation. We now have 5 of 7 C130's painted and on site at McClellan.

Mobile Equipment Program

- The Department is taking delivery of 5 new bulldozers over the next two weeks and hopes to receive 8 more before the summer.
- The facility as sustained significant recent storm damage, mainly to fencing, communication lines and two vehicles, one of which was totaled.

Cooperative Fire Protection

Cooperative Fire Programs

State and Federal Programs

- The California Fire Assistance Agreement (CFAA) meeting was held on January 10, 2023, at CAL OES to finalize proposed amendments to the existing agreement.
- The Fall Association of Contract Counties (ACC) meeting went well with positive feedback from our Contract County Partners; many thanks to all who attended and presented. The spring ACC dates will be announced soon with an additional day added for Strategic Plan discussions.

Local Government Program

- The first of four Local Government workshops will be held on January 17, 2023, in the Madera-Mariposa-Merced Unit. These workshops discuss annual updates, forecast future rates, and reaffirm processes for our Local Government Program.

State/Federal Programs

- Reimbursement processes for DR-4482 are underway working in conjunction with the Emergency Response Billing Unit. Declaration Reimbursement-4482 is the COVID Declaration approved by FEMA.
- Statewide Direct Protection Area (DPA) annual review continues with Units, Regions, and Programs. The due date was January 6, 2023 with the next phase of revising and mapping underway, including approvals by each agency signatory to the California Cooperative Wildland Fire Management and Stafford Act Response Agreement (CFMA) and the California Wildland Fire Coordinating Group (CWCG).
- The annual Continuity of Operations process is in the final stages of completion and will be submitted to CAL OES no later than January 15, 2023. Signature approvals will be sent Monday, January 9, 2023, to the Executive.

Camps and Crews Program

- The current statewide strength of Type I Hand Crews is 88 out of the 227 funded. This includes 51 California Department of Corrections and Rehabilitation (CDCR) crews staffed out of a total of 152 funded, 21 California Conservation Corps (CCC) Crews staffed out of 30 funded, 4 of the 29 funded CAL FIRE Firefighter I Crews and 12 of the 13 funded California National Guard Crews.
- The current CDCR inmate crew strength is 973 inmates out of the allocated 2584, leaving the Conservation Camp Program with a shortage of 1611 inmates. The total CDCR Camp population is at 59% with a crew capacity of 38%.
- Ben Sitter was selected as the Deputy Chief of the Camps Program effective December 1, 2022. Chief Sitter previously assumed the role of Division Chief of East Division Operations in the Sonoma-Lake-Napa Unit. We welcome Ben into his new position and congratulate him on his promotion.

Safety/EMS Program

- The EMS Program continues to work with Image Trend to add the ability to electronically transfer our CALePCR (Patient Care Report) data in real time to another agency (ambulance/paramedic provider). A statewide list of cooperating agencies using Image Trend for electronic patient care reporting (ePCR) has been forwarded to the vendor. Program has asked that the cooperating agencies in Riverside, San Diego, and San Luis Obispo counties be turned on to allow multi-directional data transfer for a pilot project. The goal remains a late January or February timeframe for this feature.
- On January 4, the EMS Program visited several Nevada-Yuba-Placer Unit (NEU) stations to meet with personnel and discuss CALePCR. Thank you to Unit Chief Brian Estes, EMS Coordinator and Fire Captain Devon Siebecke, and NEU for their continued input, feedback, and assistance in maximizing the capabilities of this product.
- The EMS Program will be hosting the EMS Workshop February 6-8 in Rancho Murieta. The EMS Coordinators have been invited to discuss topics including CALePCR, regulation updates and changes, and the role of the local EMS agencies.

- Cal/OSHA recently approved a semi-permanent Covid regulation that is expected to be effective no later than January 16. The Safety Program, Occupational Health Program, and Human Resources are working on updating the Covid Prevention Plan and positive reporting guidance. While there are a multitude of changes, none are significant.
- The Safety Program will be hosting the Safety Officer Workshop January 24-26 in San Diego. All safety officers have been invited with topics including Cal/OSHA updates, Personal Protective Equipment (PPE) changes and wear trials, cancer related studies, and items related to the Injury and Illness Prevention Program (IIPP).

Training Program

- Statewide Training
 - Progress continues to be made on the transition of employees and duties between the Statewide Training Program and CAL FIRE Training Center.
 - Efforts continue to be made on establishing the University of Phoenix, Sacramento as a statewide training site, as well as a Statewide Training Program site in Martell/Jackson.
- CAL FIRE Training Centers
 - Progress continues to be made to establish Training Center North (Redding), with a target startup date of April 2023.
 - The 2023 Academies have begun (1/9/23): Law Enforcement Regular Basic Course, Company Officer Academy (x2), Firefighter Academy (x1), and Emergency Command Center Academy
 - The recruitment of Food Service personnel continues to be a challenge, requiring contracts for feeding

Office of the State Fire Marshal

- Next Wildfire Mitigation Advisory Committee will be held today, January 17th both in person and virtually via Zoom.
 - These meetings are held on the third Tuesday of every month from 1:00-3:00 PM.

Pre-Fire Plan (Fire Plan)

- Fire Hazard Severity Zone (SRA) public hearings are ongoing.
- 7 hearings occurred in December; 51 total will be held through early February.

- The FHSZ Local Responsibility Area map roll out to follow the SRA process.

- CalMAPPER improvements continues, including build-up of mobile data entry tools & processes.

Wildfire Preparedness

Burn Permits

- The online burn permit application launched January 3rd with great success. Staff are making minor adjustments as needed. The webinar trainings were held throughout December and early January were attended by almost 1000 participants with great interaction and questions from the field that were addressed, and some comments helped make the application better.

Defensible Space Program

- Inspections ended the year with 197,411 properties inspected adding our contract county partners total of 137,931 equals 335,342 total inspections in the SRA. The additional permanent inspectors really made a significant impact on properties inspected.
- Some improvements will be done to the field map app in the near future to improve the overall application. DSpace staff is working on new material to assist the field with hiring additional inspectors and forestry technicians.
- We have hired two Fire Prevention Specialist II's that will assist the program with training our new inspectors, assessors, and DINS personnel.

California Incident Data & Statistics Program

- Made modifications to the CALFIRS Wildland Fire Cause Categories to match the National Wildfire Coordinating Group (NWCG) cause categories. This will be in line with the NWCG terminology for the field and the training that personnel are receiving at the Training Center, Unit, and Region levels.
- Along with this, we are also adding changes requested by the Utility Wildfire Mitigation program for utility-related electrical power ignitions. This includes modifications to the CALFIRS Wildland Fire Cause Subcategories for the Electrical Power category and adds a new field to indicate which Utility Company was involved.
- Program is now sending a monthly Redbook update to the Units and Contract Counties to better assist with getting the 2022 calendar year's incidents done by the February 1, 2023, deadline. We now have a live Redbook Dashboard available and reports available to Units to enhance this process.

Land Use Planning

- Numerous General Plan Safety Elements in informal review process statewide.

Subdivision Review (SDR)

- 1300+ subdivision surveys completed statewide.
- Fresno, Mendocino and several in the bay area, in progress now.

Firewise

- 640 communities in good standing, 300+ in process.

Fire Safe Regulations

- On January 4th the program conducted a training webinar for CAL FIRE Units and Contract Counties on department interpretation and enforcement.

Wildfire Prevention (WP) Grants

- WP Grants Launched the FY 2022-23 Solicitation on December 14th and will close on March 15th, 2023.
- WP Grants hosted an online workshop on January 11, 2023.
- WP Grants will also be announcing “Office Hours” during the workshop to assist perspective grantees.
 - Office Hours are the extra online technical assistance we will be providing due to the switch to Grants Portal to assist the applicants with application questions.
 - Office Hours are every Wednesday from January 25th to February 15th, 2023, from 10:00 AM to 11:00 AM.
 - The hours will be themed to various subjects including Application, Scope of work, Budget Sheet and Goals, and Project Mapping Component.
 - The listserv will be sent in the upcoming week along with updating the website.

Utility Wildfire Mitigation

- In coordination with CalStats the electrical power data schema was enhanced to include additional subcategory fields for more granularity on the root cause. Changes went into effective January 1, 2023.
- Continuing with outreach to Cooperative and Publicly Owned Utilities within CA that have infrastructure that intersects with SRA.
- Working with wildfire preparedness program on curriculum development for Powerline Fire Prevention training as it relates to PRC4292 and PRC4293 clearances and equipment ID to incorporate into the statewide Defensible Space Inspector (DSI) curriculum.
- Staff continue to work on updates to the Power Line Fire Prevention Field Guide for 2023.

- The DEI Program continues to work with the Department’s Application Services Web Master, Communications Program, amongst various programs throughout the organization,
