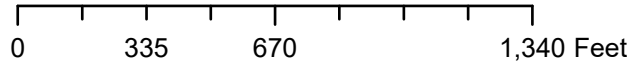

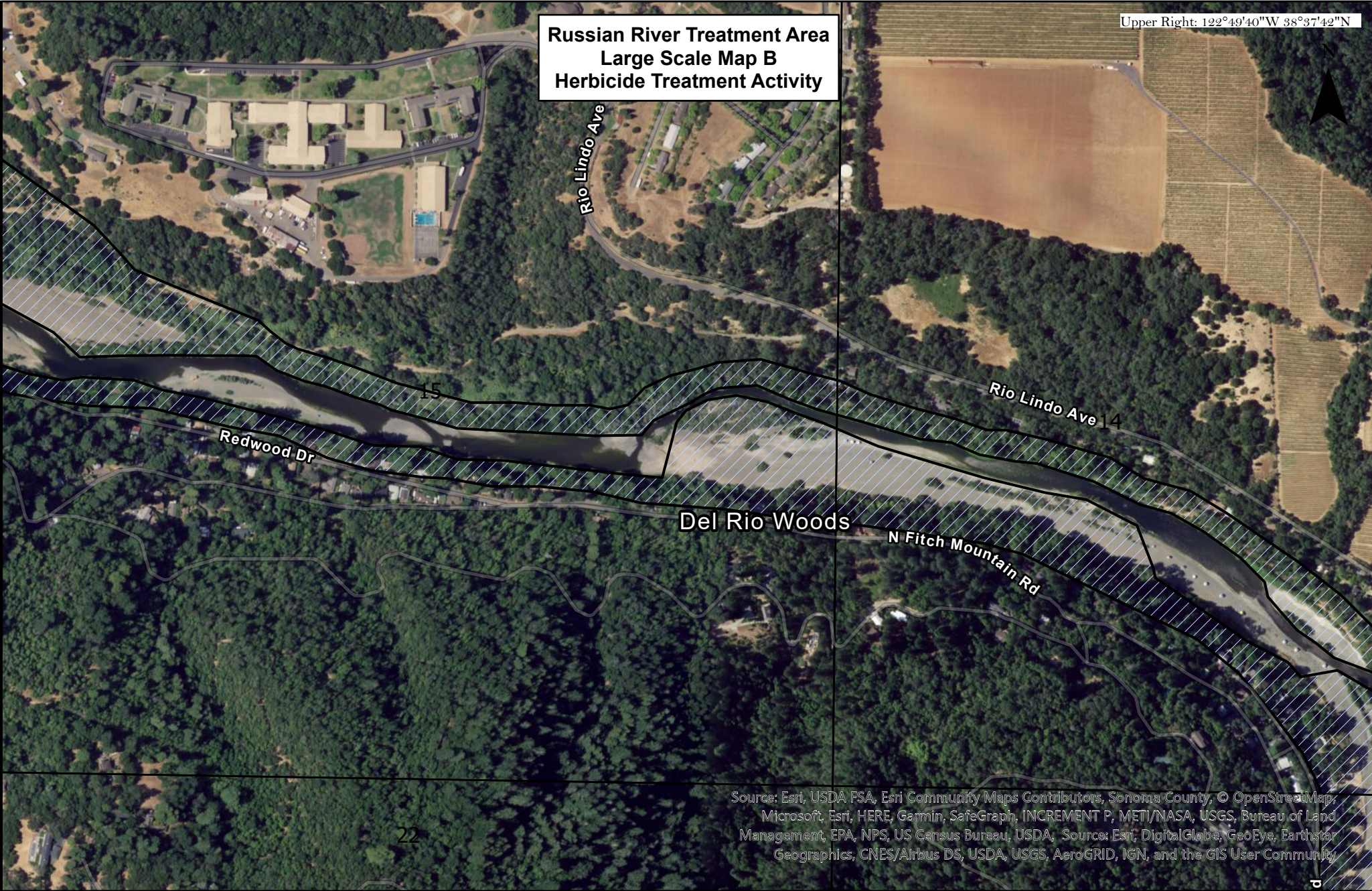

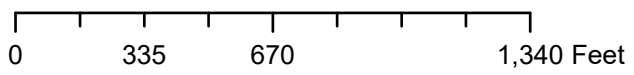
Russian River Treatment Area Large Scale Map B Herbicide Treatment Activity

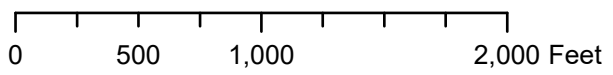

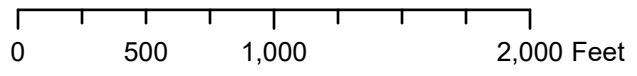
